Candidates are invited from eligible Indian Citizens for appointment as Probationary Officers (POs) in State Bank of India. The selected candidates may be posted anywhere in India.

Candidates are requested to ensure that they fulfil the eligibility criteria for the post as on the date of eligibility.

Registration is complete only when fee is deposited with the Bank through Online mode on or before the last date (25.10.2021) for payment of fee.

Candidates are advised to check Bank's website <https://bank.sbi/careers> or <https://www.sbi.co.in/careers> regularly for details and updates. No separate intimation will be issued in case of any change/ update. All important information/ corrigendum will be hosted only on Bank's website <https://bank.sbi/careers> or <https://www.sbi.co.in/careers>.

Candidates, who aspire to join State Bank of India as a Probationary Officer, should carefully read the advertisement regarding eligibility criteria, online application process, payment of application fee, issuance of call letters, process & procedures for selection/ interview, etc. and ensure that they fulfil the stipulated criteria and procedures.

Candidates are required to register on-line for the recruitment process which will be in three phases viz. (i) Phase-I; (ii) Phase-II; and (iii) Phase-III. Candidates who are shortlisted for Phase-I will have to appear for Phase-II. Candidates who are shortlisted for Phase-II will be subsequently called for Phase-III.

For interview, the candidate will have to produce a certificate from the appropriate authority inter alia stating the norms of the University/ Institute for conversion of grade into percentage and the percentage of marks obtained by the candidate in terms of these norms.

iii. Calculation of Percentage: The percentage marks shall be arrived at by dividing the total marks obtained by the candidate in all the subjects in all the year(s) by aggregate maximum marks in all the subjects irrespective of the number of additional optional subject, if any. This will be applied to all candidates.
